- All FAA members are eligible to participate, providing dues are current.
- All artwork must be received on the scheduled receiving dates and remain for the entire quarter unless sold.
- Sold pieces are to be replaced with a similarly-sized piece as soon as possible, at no additional cost.
- Artists may submit 1-5 framed pieces for the wall and 1-5 matted pieces for the bins.
- Wet or poorly prepared works requiring special handling will not be accepted.

☐ Pieces must be framed or have finished, painted edges of the canvas.

☐ Flat hardware and sufficient gauge wire must be used; no saw tooth hangers can be accepted.

☐ Label all artwork on the back with your first and last names, medium, the title of the piece, and the price.

- Artwork is installed by a committee, under the direction of the Gallery Director.
- FAA is not responsible for loss or damage and does not carry insurance on artwork.
- All participating artists must staff three 6-hour shifts each quarter. The fee for not staffing is \$40 per day.
- The Gallery Director must be notified of any changes to the staffing schedule.
- Quarterly rental fee and a \$5.00 promotional fee will be paid at the Quarterly Receiving.
- FAA will collect the appropriate sales tax and a 20% commission on sales.
- The minimum price for any item sold in the gallery is \$3.00.
- I give FAA permission to use images of my art in FAA publications, advertising, and on social media.

COST OF EXHIBITING

I. Framed Wall Art

(1) Measure width and height of artwork, including frame, rounding up to the nearest whole inch. (2) Multiply width times height to find square inches. (3) Multiply square inches times one cent (.01). (4) Multiply this number times 3 months. (5) The minimum cost is \$5.00 per month, per piece or \$15 minimum for each piece per quarter.

II. Mini-Art, Jewelry, Ceramics, Fiber Art, etc. – for display on horizontal space or garment hanger

Rental is calculated by items being grouped within a 16-inch square; this will constitute one space at \$5 per month or \$15 per quarter. Rental for garment racks will be calculated by 16-inch increments of length (16 inches = \$5 per month or \$15 per quarter). There is a \$15 minimum per quarter.

III. Bin Art – Matted, unframed artwork, 1 to 5 pieces per quarter

Cost is \$1.00 per piece x 3 months. Work must be marked with name of artist, description, and price.

IV. Cards – Members may have up to 40 cards in the gallery at no cost. Label must have artist's full name and price.
